## **TEMPORARY TRAFFIC MANAGEMENT NOTICE, VARIOUS ROADS, WEST PARLEY**

DORSET COUNCIL has issued a Notice under Section 14 [2] of the Road Traffic Regulations Act 1984 as amended. The Notice is needed in order to comply with health and safety regulations which require the provision of safe working areas and to minimise likelihood of danger to highway users. The Notice comes in to operation on 08th July 2022 between 05:00 and 18:00 and will remain in force for 5 days, however it is anticipated that the works will be completed by 14th July 2022.

## This Notice will enable Dorset Council to carry out carriageway maintenance and resurfacing works.

The effect of this Notice is as follows:


[i] All vehicles will be prohibited from proceeding along Winnards Close, West Parley from the junction and where it meets with Christchurch Road (in both directions) a distance of approximately 321 metres [ii] All vehicles will be prohibited from proceeding along Lone Pine Drive, West Parley from the junction and where it meets with Christchurch Road (in both directions) a distance of approximately 257 metres [iii] All vehicles will be prohibited from proceeding along Aldridge Road, West Parley from the junction and where it meets with Christchurch Road (in both directions) a distance of approximately 321 metres [iv] All vehicles will be prohibited from proceeding along Lone Pine Way, West Parley, from the junction and where it meets with Christchurch Road (in both directions) a distance of approximately 257 metres [v] All vehicles will be prohibited from proceeding along Dane Drive, West Parley, from the junction and where it meets with Christchurch Road (in both directions) a distance of approximately 257 metres

[vi] To impose clearway and parking suspension as indicated by signs on site to prevent waiting or parking on the highway along the above named roads above. Any vehicle waiting in contravention of any restriction imposed by this Notice may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986. A locally signed diversion route will be put in place to enable traffic to travel around the closed sections.
